

ON-LINE PARTICIPATION TERMS & CONDITIONS

1. Following terms and conditions specify the rules for on-line registration to the Digital Banking & Payments Summit 2019 (hereinafter referred to as Summit) organized on February 19-20, 2019, in Hilton Warsaw Hotel and Convention Centre by European Conferences United Sp. z o.o. (hereinafter referred to as ECU) with its seat in Kraków 30-331, ul. Ludwinowska 7/16; entered into the Register of Entrepreneurs kept by the District Court for Kraków, 11th Commercial Department of the National Court Register on 15th November 2002; under the KRS number: 0000132734; tax identification number (NIP): PL 6762228354; share capital: 50,000.00 PLN; and terms and conditions of participation in the Summit.

2. Summit participation fee per person is*:

3. The price covers lectures, conference materials, coffee breaks and lunch.

4. After filling out on-line application form at <http://www.digital-finance.pl/en/registration> the Applicant will receive an e-mail, sent to the e-mail address indicated in the on-line application form, consisting and confirming all the essential elements of concluded agreement. The e-mail message sent to the Applicant confirm legally bind agreement between applicant and the ECU and equals acceptance of the contractual obligations. For registration it is essential to indicate:

- a. data of the entity submitting for participation (hereinafter: the Applicant) – concluding the contract with ECU and obliged to pay the remuneration;
- b. name and surname of the person filling in the form in the name of the Applicant and his e-mail address. By completing the online application form on behalf of the Applicant the given person declares, that he is entitled to act in the name and for the benefit of the Applicant in the scope of concluding the contract with ECU;
- c. personal data of the Summit participants: name, surname, position, company/organization represented by the participant during the Summit, direct phone number and direct e-mail address. Providing the data is voluntary, but it is necessary to perform the contract, and due care of the data shall be taken in line with privacy policy of ECU (<https://conferences-united.eu/en/privacy-policy>).

5. The pro forma invoice will be issued and sent within 2 working days after completing on-line application form to e-mail address of Applicant or other e-mail address specified in on-line application form.

6. The person filling out on-line application form on behalf of the Applicant declares that possess the relevant authorization to act in the name of and on behalf of the Applicant, specifically to conclude an agreement with ECU.

7. We kindly ask you to make a payment within 7 days from sending the registration form however no later than 5 working days before the start of the Summit.

8. In the case of registration before December 14, 2018 and failure to cover the full participation fee before January 25, 2019, the cost amounts to 3995 PLN + 23% VAT per person.

10. The Applicant has the right to withdraw from participating on the terms and conditions indicated below. Resignation from participation should be made and sent by e-mail to edyta.olbratowska@conferences-united.eu

11. In the case of resignation until January 25, 2019 the Applicant is obligated to pay a service fee in the amount of 1000 PLN + 23% VAT for every cancelled registration.

12. In the case of resignation after January 25, 2019 the Applicant is obligated to pay the full participation costs, in the amount resulting from the agreement concluded between the Applicant and ECU.
13. In the case of the lack of participation in the Summit as well as the lack of the written resignation from participation in the Summit, the Applicant is obligated to pay the full participation costs in the amount resulting from the agreement.
14. Default in payment shall not be unambiguous with resignation from the participation.
15. A person indicated by the Applicant (from Applicant's company / organization) may participate in the Summit in lieu of the person submitted to participate.
16. ECU reserves the right to change the program, the venue of the Summit as well as cancel the Summit.
